- 1. The Board will vote to approve the Open Meeting Minutes from the December 14, 2021 Select Board Meeting.

The application will be subject to further review and subsequent permission/denial from both the Conservation Commission and the Select Board to conduct the proposed work. Permission to file a Notice of Intent <u>is not an approval</u> <u>of the project</u> and, thus, it should not be construed as granting any rights or permission to the applicant to proceed with the proposed project. Approval of this administrative note simply gives the applicant <u>permission to file</u> the Notice of Intent with the Conservation Commission.

- 4. The Board will vote to approve the use of ARPA Funds in the amount of \$80,000 to be used for the Outdoor Dining Project in Plymouth.
- 5. The Board will vote to approve the use of ARPA Funds in the amount of \$153,200 to be used for the purchase of Covid-19 Testing Kits.
