- 1. The Board will vote to approve the Open Meeting Minutes from the February 22, 2022 Select Board Meeting.
- 2. The Board will vote to appoint Mary Ann Veiga to the Plymouth Housing Authority in the Tenant Position for a term beginning on May 21, 2022 and terminate on May 15, 2027.

- 3. The Board will vote to increase the Spending Cap by \$75,000 for the Recreation Revolving Fund. The current Spending Cap is \$500,000 and the requested new Spending Cap would be \$575,000.
- 4. The Board will vote to change the name of the Agricultural Committee Gift Account to the Agricultural Commission Gift Account.
- 5. The Board will vote to Accept a Gift in the amount of \$250 for the Plymouth Agricultural Commission from the Plymouth Garden Club.
- 6. The Board will approve and execute a five-year Host Community Agreement with Two Seven Plymouth, Inc. for the operation of a licensed Marijuana Retail, Cultivation and Marijuana Product Manufacturing facility at 27 Robert J. Way, contingent upon the finalization of a business agreement that will formally terminate any affiliation between Two Seven Plymouth, Inc. and CannaVana, Inc.

The Board will authorize the application for, and acceptance of, grant funds in the amount of \$21,000 from the Massachusetts Executive Office of Public Safety & Security's Office of Grants & Research, in accordance with Section 53A of Chapter 44 of the Massachusetts General Laws. These grant funds will be used to reimburse the Town for the expense of training seven (7) employees through the Municipal Police Training Committee's FY2022 Bridge Academy Training Program.
