- 3. The Board will vote to appoint Daniel Baldassini to the Climate Action Net Zero Committee for a term beginning immediately and terminating on June 30, 2025.
- 4. The Board will approve and execute a *License Agreement* between the Town (as Licensor) and Scott A. Belval and Tracy C Belval, owners of 216 Manomet Point Road (as Licensee), which shall authorize (1) regulated, temporary vehicular access over Boat House Lane and public coastal beach property located off Manomet Point Road, and (2) the encroachment, construction, and maintenance of an erosion control revetment upon Town-owned coastal beach property identified as Lots A-O-5Z and A-N-5Z on Plymouth Assessor's Map 46.

The Board will approve and execute a five-year Host Community Agreement with Two Seven Plymouth, Inc. for the operation of a licensed Marijuana Retail, Cultivation and Marijuana Product Manufacturing facility at 27 Robert J. Way, contingent upon the finalization of a business agreement that will formally terminate any affiliation between Two Seven Plymouth, Inc. and CannaVana, Inc.
