9. The Board will vote, as Water Commissioners, to authorize the following mandatory outdoor watering restrictions:

*During the period of May 1, 2022 through September 30, 2022 outdoor watering shall be restricted to 60 minutes per day. Even numbered homes shall be permitted to use outdoor water for up to 60 minutes on Tuesdays, Thursdays, and Saturdays only. Odd numbered homes shall be permitted to use outdoor water for 60 minutes on Wednesdays, Fridays, and Sundays. Such watering shall be permitted between the hours of 5:00am to 7:00am and then again from 5:00pm to 7:00pm. No outdoor watering is allowed between 7:00am and 5:00pm Tuesday through Sunday and no outdoor watering for all of Monday.*
