- 1. The Board will vote to approve the Open Meeting Minutes from the March 22, 2022 Select Board Meeting.
- 2. The Board will vote to approve the re-painting of the Pride Crosswalk on Water Street as previously voted.
- 3. The Board will vote to approve a Temporary Agreement between the Town of Plymouth and The Public Meeting House for the use of about 25 square feet of property on Burial Hill in order to install a new transformer. (See attached plan)
- 4. The Board will vote to authorize the application for, and acceptance of, grant funds in the amount of \$197,340 through the Massachusetts Department of Transportation's Shared Streets & Spaces Grant Program for the implementation of traffic calming measures on Standish Avenue and Sandwich Street.
- 5. The Board will vote authorize the application for, and acceptance of, grant funds in the amount of \$48,500 through the Massachusetts Department of Transportation's Shared Streets & Spaces Grant Program for the purchase and installation of traffic calming and pedestrian safety equipment on multiple streets, including Samoset Street and Clark Road.

- 6. The Board will vote to authorize the application for, and acceptance of, grant funds in the amount of \$28,000 through the Massachusetts Department of Transportation's Shared Streets & Spaces Grant Program for the purchase and installation of traffic calming and pedestrian safety equipment on Summer Street.
- 7. The Board will vote to authorize the application for, and acceptance of, grant funds in the amount of \$33,117 through the Massachusetts Interlocal Insurance Association's FLEX Rewards Grant Program for the purchase of safety and loss control equipment for multiple departments.
- 8. The Board will vote to approve and execute a five-year Host Community Agreement with Healing Gardens LLC for the operation of a licensed Marijuana Cultivation and Product Manufacturing facility at 19 Richards Road.
- 9. The Board will vote to approve and execute a five-year Host Community Agreement with The Botanist, Inc. for the operation of a licensed Marijuana Retail, Cultivation, and Product Manufacturing facility at 8 Scobee Circle, contingent upon the completion of the sale transaction between Alfred's Finest, Inc. and The Botanist, Inc.
- 10. The Board will vote to approve and execute a five-year Host Community Agreement with Two Seven Plymouth, Inc. for the operation of a licensed Marijuana Retail, Cultivation, and Product Manufacturing facility at 27 Robert J. Way, contingent upon the finalization of a business agreement that will formally terminate any affiliation between Two Seven Plymouth, Inc. and CannaVana, Inc.
- 11. The Board will vote to waive the 15-day veto period per Section 3-5-1 of the Town Charter and confirm Kelly McElreath as the Town Clerk.
