## HOLTEC PILOT LEGISLATION AMENDMENT

Mr. Brindisi stated that when the PILOT needs to be amended, the Board must approve said amendments.

Mina Makarius, Special Town Counsel, stated that the proposed amendments are minimal. Mr. Makarius stated that the Division of Local Services and the Department of Revenue recommended additional comments, and suggested minor changes. Mr. Makarius stated that the amendments are to language to make it clear the PILOT has to be agreed upon by both sides. Mr. Makarius described a second amendment to the language of “and the subsidiaries” to “or a subsidiary thereof”. Mr. Brindisi noted that the amendments are to make clear that Holtec would explicitly enter into a PILOT with the Town of Plymouth Select Board.

On a motion by Richard Quintal and seconded by Charlie Bletzer, the Board voted to approve the amendments to the Holtec PILOT Legislation as presented, with minor revisions made by Town Counsel.
