At request of Select Board, Attorney Bergeron, in-house counsel for Plymouth, provided overview of litigation brought against the town by Attorney Meg Sheehan, including total open meeting law complaints, appeals of the complaints to A.G. Office, 40A appeals filed with Plymouth Superior Court. Litigation brought by Attorney Sheehan against the town indicates an office address listed at town property of 158 Center Hill Road. Review of the lease between the town and lessee indicates Attorney Sheehan is not a lessee, nor approved as a sub-tenant – for which lessee had previously gone through the process of approving other subtenants. Documents in possession of Attorney Bergeron, for which he gave an oral presentation, were articles of organization for Save the Pine Barrens (SPB) (Attorney Sheehan,'s organization) dated March 5, 2021; OML Complaints filed by Attorney Sheehan, Superior Court filings filed by Attorney Sheehan, and all of which indicate an office address

for Attorney Sheehan at 158 Center Hill Road. Also discussed was an email from the vice-president of lessee to town manager on March 5, 203, which indicated Attorney Sheehan/SPB had used the town facility for meetings, conferences, webinars, social gatherings.

After oral presentation, all board members had questions regarding Attorney Sheehan's use of the premises regarding the lease between the town and lessee at 158 Center Hill Road. Topics discussed relevant to the lease included term of the lease, renewal of the lease, approved subletting of the lease, default clause, and notice to lessee of potential default.

Attorney Bergeron indicates he would need additional time to review whether lessee is presently in default of lease.

On a motion by John Mahoney and seconded by Harry Helm, the Board voted to adjourn Executive Session at 5:58 p.m., and go back to Open Session. At the adjournment of Open Session the Board will continue in Executive Session.

Mr. Brindisi said the Town's existing PEC Agreement is through the end of FY24. Mr. Brindisi said that the proposed PEC Agreement will begin at FY24. Mr. Brindisi said that there are significant cost saving measures for the Town, employees, and retirees.

Ms. Barrett described the FY24 cost savings of \$3.1 million, which includes an adoption of a PillarRx Coupon Program, and to convert the retirees to a Medicare Part D Prescription Drug Program. Ms. Barrett described the FY25 cost savings of \$476,000, and in FY26 a projected cost savings of \$1.7 million (all active employees convert to the premium contribution of 70% Town and 30% Employee).

On a motion by John Mahoney and seconded by Richard Quintal, the Board voted to approve and execute the proposed PEC Agreement.
