ARPA AMENDMENT REQUEST

Mr. Brothers said that the ARPA Amendment Request is for an additional \$10,000 due to the flowers and landscaping being more expensive than originally budgeted. Mr. Brothers said that for future years, the costs of the outdoor dining fees would fully cover all maintenance costs associated with the parklets, and would not rely on ARPA funding.

On a motion by Charlie Bletzer and seconded by John Mahoney, the Board voted to approve the ARPA Amendment to allocate an additional \$10,000 for outdoor dining parklet flowers as presented.

PUBLIC COMMENTS

Richard Serkey, Precinct 2 Town Meeting member, said that he believes at a previous Board meeting, Mr. Bletzer said that the Proposed Town Charter was prepared by a biased commission, and a biased chairman. Mr. Serkey said that he believed that was uncalled for, and that the members of the Commission were elected by Town citizens. Mr. Serkey said that he believes the cost estimate of the proposed implementation of the Town Charter has no evidence. Mr. Serkey said that he believes that Chairman Cavacco should not speak against the Charter Commission. Ms. Cavacco said that she will continue to state her opinion when she is on the Board. Ms. Cavacco said that she believes that Mr. Serkey is constantly criticizing the Board.

Steve Lydon, said that he would not vote for the Proposed Town Charter, because it is an inefficient form of Town government.

PROPOSED ADIRONDACK CHAIR

Kate Thayer, Downtown Waterfront District representative proposed a large Adirondack chair be installed in the Downtown area. Ms. Thayer stated that the proposed chair would be made by a resident, who has made chairs for other communities in Massachusetts. Ms. Thayer said that See Plymouth is in support of this installation. Ms. Thayer said that she has met with the DPW to put the chair in the village marketplace. Ms. Thayer said that the chair would be painted blue, and would say "Welcome to Plymouth Massachusetts, America's Hometown". Ms. Thayer outlined the guidelines the DPW has outlined in regard to the installation and placement of the chair.

Ms. Cavacco said that the placement in the marketplace doesn't allow for enough pedestrian access, and she suggested that the chair be placed at Town Hall. Mr. Brindisi said that there is not enough room in Town Hall, due to the various events that occur throughout the year.

On a motion by Betty Cavacco and seconded by Harry Helm, the Board voted to approve the request to install an Adirondack chair at Shirley Square, with the guidance of the DPW. *Voted 5/0 By Roll Call: Mahoney-Yes, Cavacco-Yes, Helm-Yes, Bletzer-Yes, Quintal-Yes.*

FRESH POND RECREATIONAL AREA DISCUSSION

Ms. Cavacco requested that the Town remove the rusted playground equipment at Fresh Pond Recreational Area. Mr. Bletzer and Mr. Helm agreed that it needs upgrading. Mr. Brindisi said that he would work with Mr. Faiella to identify solutions for the playground.

TOWN MANAGER'S REPORT

Mr. Brindisi said that the Town has received approximately \$240,000 through the national opioid settlement against Johnson and Johnson and other opioid manufacturers. Mr. Brindisi said that the funds will currently go to the General Fund, however, at the 2023 Fall Town Meeting, the funds will be reappropriated with an article, with a plan to distribute the funds in a fair and equal manner.

Mr. Brindisi said that Inspectional Services will remove any political signage in public spaces and will return the signage to the owner.

Mr. Brindisi said that the Spire Center construction grant agreement was executed last week. Mr. Brindisi said that construction will begin to occur in the next 30 days. Mr. Brindisi noted that meetings are occurring regarding ensuring ADA access to the entrances.

Mr. Brindisi said that an updated report regarding the Water Street Interceptor Replacement project was slated to be received today. Mr. Brindisi said that he will inform the Board and the public of any updates moving forward.

Mr. Brindisi and Mr. Mahoney described an unofficial agreement that was made with members of CPC and a property owner, that a water and sewer connection would have occurred about a CPA article. Mr. Brindisi said that Town staff did not know about this apparent "agreement" at Stephens Lane. Ms. Cavacco said that she was concerned that the Chair of the CPC, "negotiated" on behalf of the Town. Ginny Davis, League of Women Voters observer, said that she is concerned with this revelation.

SELECT BOARD OPEN DISCUSSION

Mr. Bletzer described an upcoming film screening regarding a movie about children who have autism.
